Client Authority

This authorisation includes, but is not limited to, HMRC matters related to my National Insurance and HRP position. Evanshaw Ltd may:

- Communicate with HMRC by phone, post, or digitally.
- Request and receive my National Insurance and HRP records from HMRC.
- Prepare, submit, and manage all documentation and forms relevant to my HRP/NI-related claim(s) with HMRC (including CF411 and any supporting correspondence).

- Liaise with HMRC to clarify any discrepancies or provide supporting information.
- Receive correspondence from HMRC directly related to my National Insurance, HRP and related State Pension entitlement.

I consent to Evanshaw Ltd handling my personal data solely for the purposes of processing my claim(s), in accordance with the UK GDPR and Data Protection Act 2018, as set out in their Privacy Notice.

Extended Authority (HMRC only)

This authority covers all HMRC-held matters relating to my National Insurance record, HRP and related State Pension entitlement. Evanshaw Ltd may:

- Request and receive my National Insurance statements, contribution history, credits, and qualifying years from HMRC.
- Request and receive any information HMRC holds that is relevant to HRP credits or qualifying years used in calculating my State Pension entitlement.
- Request and receive copies of any HMRC correspondence or records relating to National Insurance, HRP and any corrections, recalculations, or reviews that affect my State Pension entitlement.
- Liaise with HMRC to clarify calculations and obtain access to relevant internal notes or records necessary to determine or correct my National Insurance/HRP position.

This Letter of Authority does **not** authorise Evanshaw Ltd to act for me in relation to other, unrelated tax matters unless separately agreed. We understand HMRC can only provide information it holds and will not disclose any data held exclusively by the Department for Work and Pensions (DWP).

Repayment Nomination – HMRC only

I authorise Evanshaw Ltd to receive, as my **bare nominee**, any back-dated arrears/back-payments issued by **HMRC** as a result of my HRP/NI-related claim(s), where HMRC allows such a nomination. This is a **nomination only** and is intended to operate in accordance with **HMRC PAYE Manual PAYE91040 (Nominees)**. I may withdraw this nomination at any time before HMRC issues any repayment under it.

• Evanshaw may request **HMRC** to issue any such arrears/back-payments to Evanshaw Ltd as my nominee, solely so Evanshaw can deduct its agreed fee

under my Conditional Fee Agreement (CFA) and promptly remit the balance to me.

- The success fee is 30% plus VAT at the standard rate (currently 20%), which together equals 36% of arrears/back-payments actually received (net of any HMRC set-offs), as set out in Evanshaw's Terms & Conditions and CFA.
- If **HMRC** pays me directly, I agree to pay Evanshaw's fee under the CFA within the timescale set out in that agreement.
- Any repayment received by Evanshaw on my behalf will be held on trust for me and the balance (after fee deduction) paid to my nominated bank account within 7 working days of clearance.
- Following Spring Budget 2023, assignments of income tax repayments are void. This Letter of Authority uses a bare nomination only and does not assign any repayment.

For the avoidance of doubt, **DWP** arrears are not covered by this nomination and must be paid directly to me. Any separate authority for DWP (including HRP-related State Pension correction and Pension Credit) is dealt with under a separate **DWP** Letter of Authority.
